- IV. New Business
 - A. Discussion regarding stormwater management

Mr. Krack provided some preliminary information on the steps being taken by the Borough to address the concerns of the residents when it comes to stormwater management. He stated that he hoped to have more information to share regarding the findings of the Borough Engineer this committee's next meeting. He stated that if the state legislature approves a bill allowing Boroughs to develop stormwater management, Staff will begin the process of drafting an ordinance for stormwater basin maintenance on properties within the Borough.

 - A. Somax Proposal Update Digester #2

Mr. Krack provided the update regarding the Non-Disclosure Agreement (NDA) with Somax and how it may affect the design of Digester #2. Until more information is gathered he believes the design and engineering on Digester #2 should be suspended.

Mr. Ewald made a Motion to recommend suspension of the design and engineering of Digester #2. Seconded by Mr. Dalton.

Motion Approved 4-0.

B. Hankin Group Proposal – Update – Neal Fisher

Mr. Krack explained the next steps in the process and the committee asked Mr. Fisher if he could bring a presentation to the next Council Meeting on July 10, 2018.

C. Capital Projects Update:

Main Street Trestle Jacking - CDBG Grant

Mr. Watson provided the update on both replacement programs, He stated that the replacement on Starr Street is still ahead of PennDOT's paving project.

G. Streetscapes

Mr. Kovaleski made a Motion to refer the proposal for the street light painting, in blue to match the downtown, to Finance for recommendation. Seconded by Ms. Burckley.

Ms. Getzfread reported staff has begun the process for the Civic Plus suite of products. The project should be completed for a mid-January 2019 launch.
