Beautification Advisory Commission

The Commission fosters public awareness and appreciation for the physical environment of Phoenixville; creates educational programs that promotes the community aesthetic; develops public art that both respects the historic significance and the diversity of the community; secure the resources that enable the development and maintenance of ongoing initiatives; and review submissions and approve the process for all public art in the Borough.

Board of Appeals

Hears appeals from decisions of the Borough of Phoenixville Building Official which are filed pursuant to the Construction Code Act and the Borough's Building Codes; appeals from decisions of the Borough of Phoenixville Fire Code Official which are filed pursuant to the International Fire Code; and appeals from decisions of the Borough of Phoenixville Code Official which are filed pursuant to the International Property Maintenance Code.

Civil Service Commission

Make rules and regulations providing for the examination of applicants for positions in the police force and as paid fire apparatus operators and for promotions, which rules and regulations shall prescribe the minimum qualifications of all applicants to be examined and the passing grades.

Historical and Architectural Review Board

Advances the preservation and protection of the old historic district, architecturally worthy structures, and landscape features, as well as the quaint neighborhoods, which impart a distinct aspect and character to the Borough of Phoenixville, and which serve as visible reminders of the historical and cultural heritage of the Borough of Phoenixville, the commonwealth, and the nation.

Human Relations Commission

Initiates, receives, investigates and seeks the satisfactory adjustment of complaints charging unlawful practices which the Commission believes may constitute a discriminatory violation of a law of the United States of America, the Commonwealth of Pennsylvania, or the Borough of Phoenixville.

Planning Commission

Prepares the comprehensive plan; recommends the adoption or amendment of an official map; prepares the Borough's zoning ordinance and makes recommendations to the on proposed amendments to it; and prepares, recommends and administers subdivision and land development and planned residential development regulations;

Recreation Board

Makes recommendations to Borough Council for the maintenance, equipment, operations, and supervision of Borough parks, playgrounds, playfields, and other outdoor and indoor recreation areas and facilities owned or controlled by the Borough of Phoenixville

Tree Advisory Commission

Promotes public support for, interest in and involvement in street tree and public tree programs in the Borough. Works to involve neighborhoods in street tree planting, maintenance and removal planning and policies. Provides a forum for private groups and individuals interested in street tree and public tree programs to coordinate their efforts, to facilitate reaching consensus on policy recommendations and to organize community input for the Manager, the Council and the Mayor.

Zoning Hearing Board

Considers applications for variances, special exceptions, appeals concerning the interpretation of the Borough's Zoning Ordinance by the Zoning Officer and other duties that are specified by the Borough Code.
